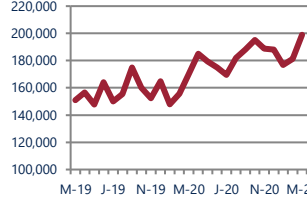

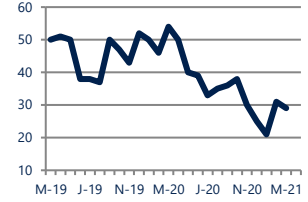

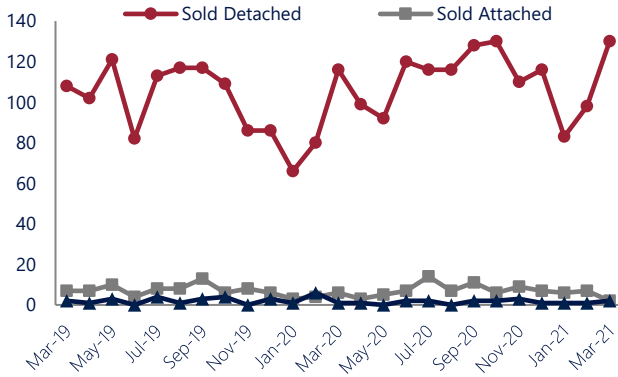

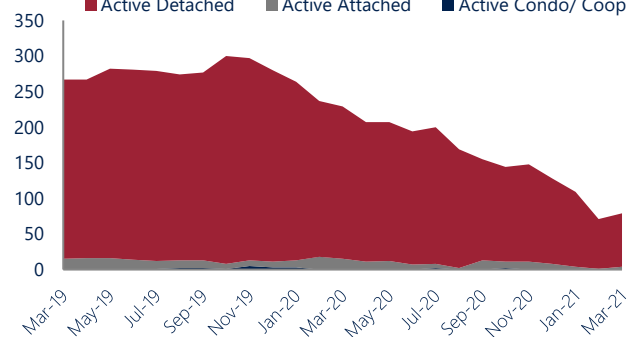
**Units Sold**

There was an increase in total units sold in March, with 134 sold this month in Randolph County versus 106 last month, an increase of 26%. This month's total units sold was higher than at this time last year, an increase of 9% versus March 2020.

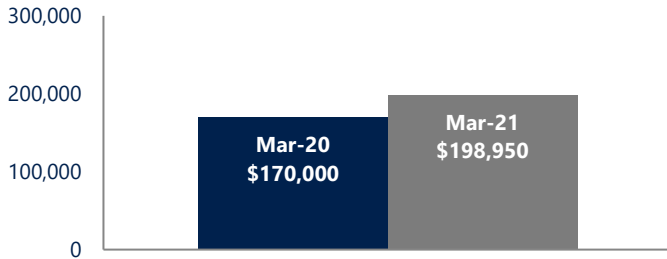
**Active Inventory**

Versus last year, the total number of homes available this month is lower by 150 units or 66%. The total number of active inventory this March was 79 compared to 229 in March 2020. This month's total of 79 is higher than the previous month's total supply of available inventory of 71, an increase of 11%.

Last March, the median sale price for Randolph County Homes was \$170,000. This March, the median sale price was \$198,950, an increase of 17% or \$28,950 compared to last year. The current median sold price is 10% higher than in February.

Median sale price is the middle sale price in a given month. The same number of properties are above & below the median.



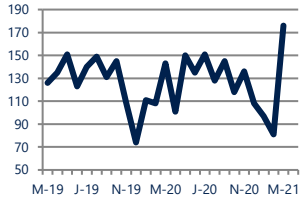

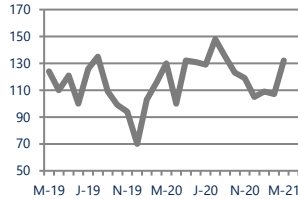

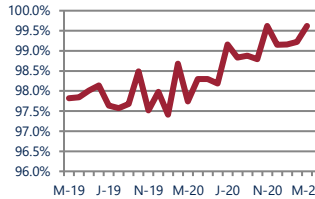

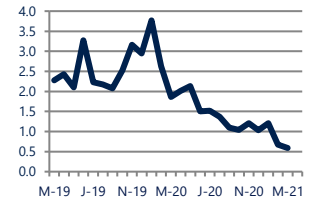

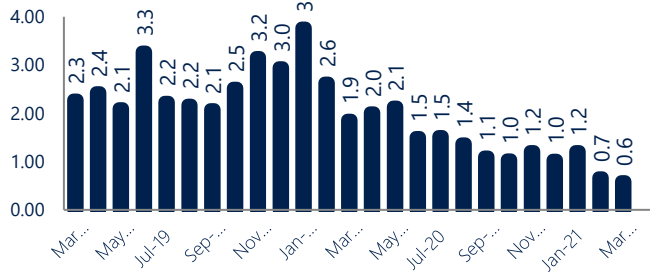

### Months of Supply

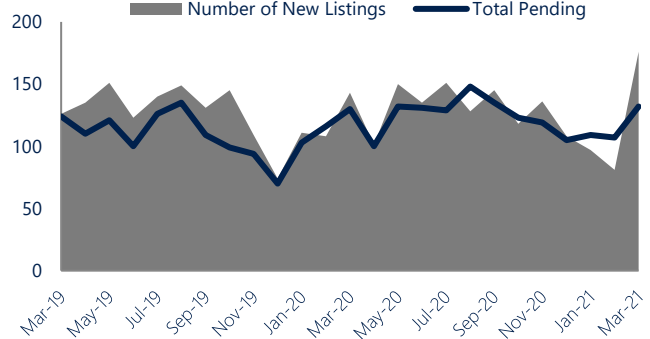
In March, there was 0.6 months of supply available in Randolph County, compared to 1.9 in March 2020. That is a decrease of 68% versus a year ago.

Months of supply is calculated by dividing current inventory by current sales. It indicates how many months would be needed to sell all of the inventory available at the current rate of demand.

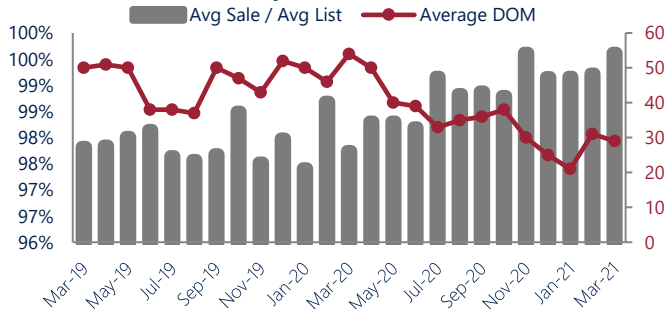
### New Listings & Current Contracts

This month there were 176 homes newly listed for sale in Randolph County compared to 143 in March 2020, an increase of 23%. There were 132 current contracts pending sale this March compared to 130 a year ago. The number of current contracts is 2% higher than last March.
