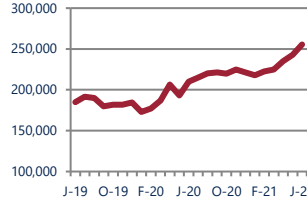

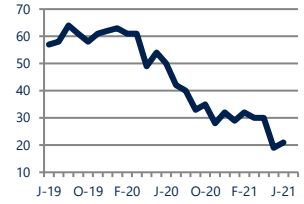

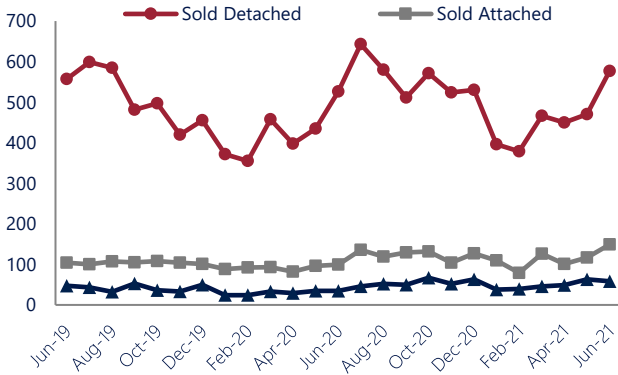

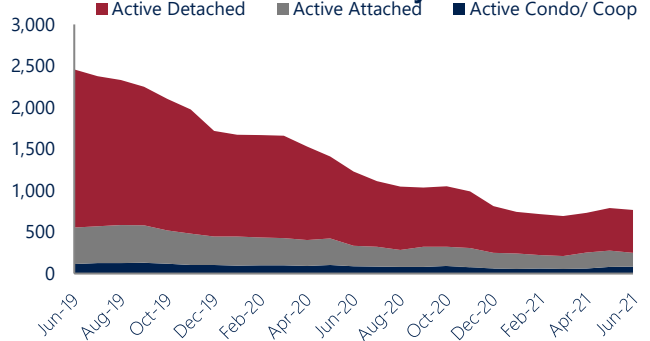
Units Sold

There was an increase in total units sold in June, with 784 sold this month in Camden County versus 650 last month, an increase of 21%. This month's total units sold was higher than at this time last year, an increase of 19% versus June 2020.

Active Inventory

Versus last year, the total number of homes available this month is lower by 461 units or 38%. The total number of active inventory this June was 767 compared to 1,228 in June 2020. This month's total of 767 is lower than the previous month's total supply of available inventory of 790, a decrease of 3%.

Median Sale Price

Last June, the median sale price for Camden County Homes was \$210,000. This June, the median sale price was \$255,500, an increase of 22% or \$45,500 compared to last year. The current median sold price is 5% higher than in May.

Median sale price is the middle sale price in a given month. The same number of properties are above & below the median.

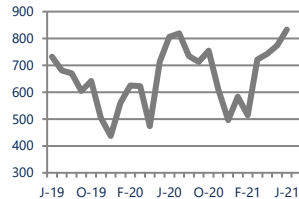

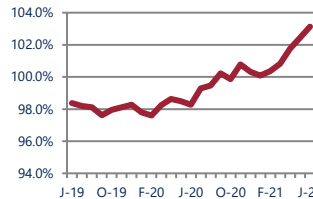

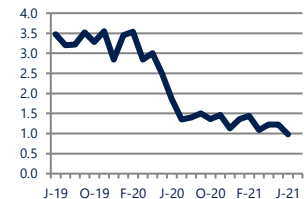

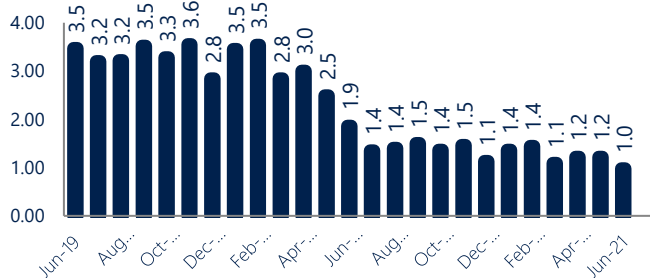

New Listings & Current Contracts

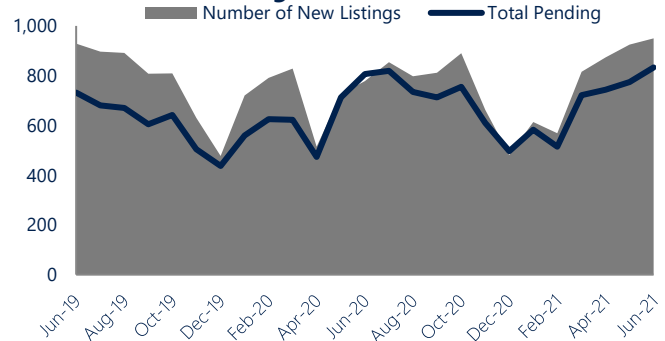
This month there were 950 homes newly listed for sale in Camden County compared to 778 in June 2020, an increase of 22%. There were 833 current contracts pending sale this June compared to 806 a year ago. The number of current contracts is 3% higher than last June.

Months of Supply

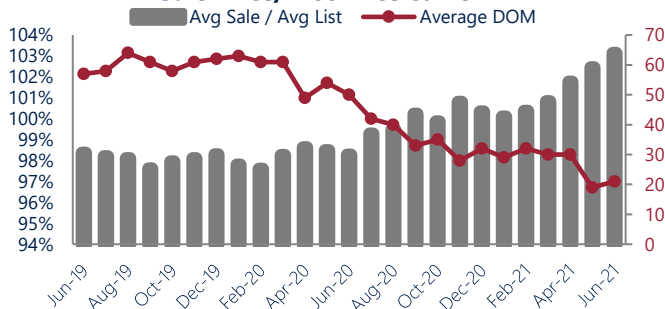
In June, there was 1.0 months of supply available in Camden County, compared to 1.9 in June 2020. That is a decrease of 47% versus a year ago.

Months of supply is calculated by dividing current inventory by current sales. It indicates how many months would be needed to sell all of the inventory available at the current rate of demand.

In June, the average sale price in Camden County was 103.1% of the average list price, which is 4.9% higher than at this time last year.

Days On Market

This month, the average number of days on market was 21, lower than the average last year, which was 50, a decrease of 58%.
