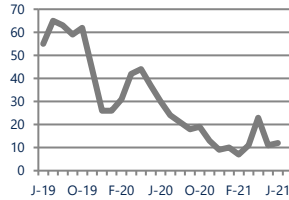

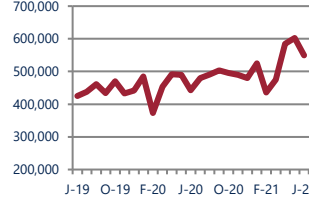

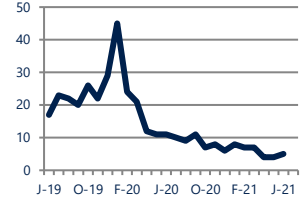

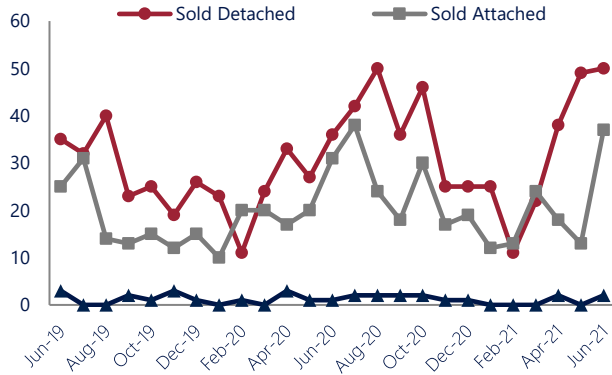

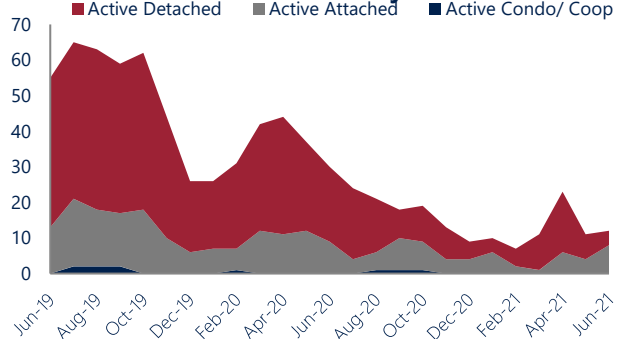
### Units Sold

There was an increase in total units sold in June, with 89 sold this month in Bristow. This month's total units sold was higher than at this time last year.

### Active Inventory

Versus last year, the total number of homes available this month is lower by 18 units or 60%. The total number of active inventory this June was 12 compared to 30 in June 2020. This month's total of 12 is higher than the previous month's total supply of available inventory of 11, an increase of 9%.

### Median Sale Price

Last June, the median sale price for Bristow Homes was \$443,000. This June, the median sale price was \$549,000, an increase of 24% or \$106,000 compared to last year. The current median sold price is 9% lower than in May.

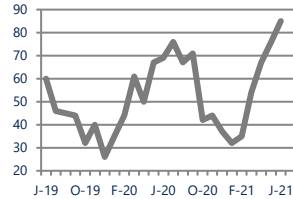

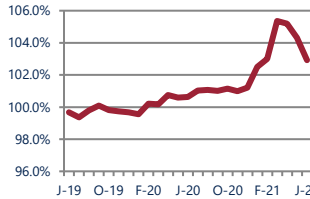

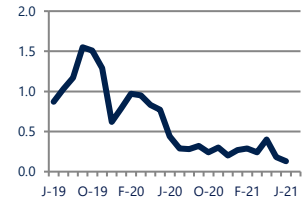

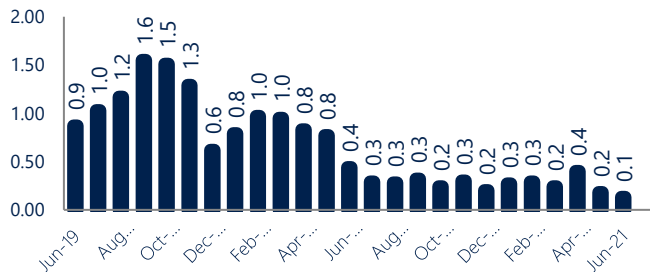

### New Listings & Current Contracts

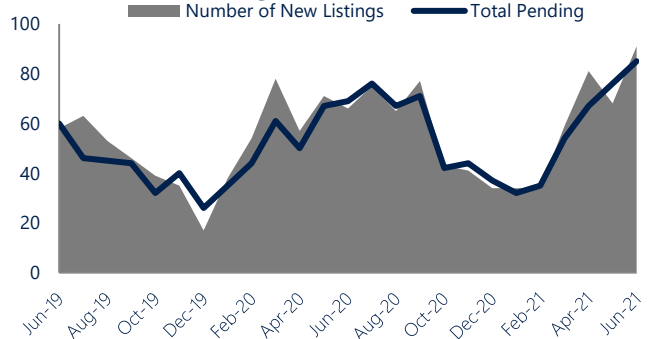
This month there were 91 homes newly listed for sale in Bristow compared to 66 in June 2020, an increase of 38%. There were 85 current contracts pending sale this June compared to 69 a year ago. The number of current contracts is 23% higher than last June.

### Months of Supply

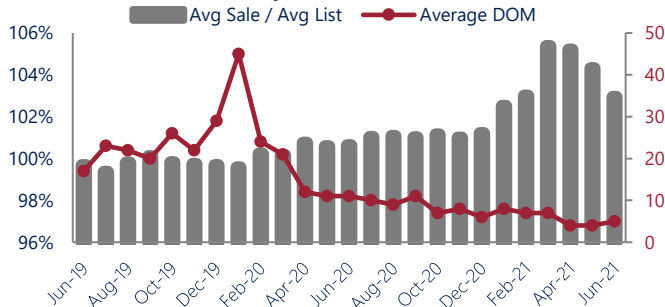
In June, there was 0.1 months of supply available in Bristow, compared to 0.4 in June 2020. That is a decrease of 69% versus a year ago.

Months of supply is calculated by dividing current inventory by current sales. It indicates how many months would be needed to sell all of the inventory available at the current rate of demand.

### Sale Price to List Price Ratio

In June, the average sale price in Bristow was 102.9% of the average list price, which is 2.3% higher than at this time last year.

### Days On Market

This month, the average number of days on market was 5, lower than the average last year, which was 11, a decrease of 55%.
